**Updates from Council Members**

**A. President**

**a. UPS Updates**

**i. UPS Summer Package**

- Textbook sales (i.e. CTC, CTMA, RxFiles, Dipiro) will continue to be done through CAPSI's partnership with CPhA. The UPS Summer Package will be sent out tomorrow for upper year students though the order form for textbooks and clothing/apparel will be sent out at a later date once pricing and delivery details are finalized.
- As we are unsure of the order & delivery timeline currently, pick-up times & dates are TBD (likely to be some time late Sept to mid-October). In-person pick-ups will have to follow the LDFP building's social distancing restrictions. UPS members will be having a meeting with some of the Faculty members this week to discuss logistics so an update will be provided later on.
- Delivery options are being considered for those who are unable to pick-up their orders in person, though it may be quite costly as it's estimated to be about \$15 for deliveries within the GTA (likely to be more expensive if delivering outside GTA). We're currently unsure if UPS or class council will have the funds to absorb some of the shipping costs but more updates will be provided later on.
- The CTC edition that is currently being sold on the CPhA website is the 2019 edition. We will follow up to see when the 2020 edition

will be available and may delay pick-ups to a later date if the 2020 edition comes out later.
